With numerous publications in peer reviewed journals one of the leading researchers in the international field of Body Image Phenomenology and Body Psychotherapy in Mental Illness; book publications include co-editor of Handbook of Body Image Research and books on bodypsychotherapy; monography from 2000 is the first textbook covering the innovative field of bodyoriented psychotherapy in psychiatry. Research focus: development and evaluation of treatment manuals for body oriented, non-verbal psychotherapeutic intervention strategies (anorexia nervosa, somatoform disorders, depression, schizophrenia).
